



# Pasadena Strawberry Festival 2018 Baby Float Parade



The Baby Float Parade is one of the most charming parts of the Pasadena Strawberry Festival. It involves the creativeness of the parents and the beauty of the child celebrating the strawberry motif. The babies will appear in a decorated wagon, cart, carriage, stroller, or anything else on wheels making up a tiny float. This contest is open to children 3 months to 4 years of age.

On May 19th, during the Pasadena Strawberry Festival in Campbell Hall (enter off Red Bluff). Enter Festival through Orange Ticket Gate, you will report to Campbell Hall and there you will pick up your numbers and at 11:00 the parade will start going down the Midway , loop back and end back at Campbell Hall for awards. There will be 5 awards presented. The categories are: Most Creative Entry, Most Beautiful Entry, Best Texas Theme, & Best use of strawberries.

Each entrant will receive two passes to the Strawberry Festival to be used to participate in the parade on Saturday May19th, 2018. All children under 5 years old are FREE. We ask that all winners' floats be left in Campbell Hall to be on displayed for all Festival Patrons to view. Your floats are to be picked up at the close of Festival at 6:00 PM on Sunday and no later than 7:00 PM. Campbell Hall has to be empty by that time.

It is important that all Baby Float Parade participants **pre-register by May 13th**, so as to receive your tickets for that Saturday morning (May 19th) to get into the festival. Those choosing not to pre-register will have to pay gate admission to be able to enter the Baby Float Parade. **No Charge to pre-register.**

In consideration of entry into and participation in the activities associated with the PASADENA STRAWBERRY FESTIVAL (collectively, the FESTIVAL) and in recognition of the risk of injury while participating in FESTIVAL activities and as consideration for the right to participate in the activities, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this WAIVER and RELEASE OF LIABILITY and hereby WAIVE any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation and do hereby RELEASE and forever discharge THE PASADENA STRAWBERRY FESTIVAL and their affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns and all sponsors and/or beneficiaries of the FESTIVAL from any and all liability, claims, demands, damages, actions or causes of action of every kind and character now existing or which hereinafter may arise as a result of my participation regardless of cause or whether any injury is caused by the sole, joint, comparative, or concurrent negligence or gross negligence or fault of the FESTIVAL, the negligence or fault of myself or third parties, the conditions of the event site or any other cause.

Further and for the consideration herein described, I agree to INDEMNIFY and HOLD HARMLESS the FESTIVAL against any and all claims, demands, damages, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorneys fees, if litigation arises on account of claims made by me or anyone on my behalf caused by negligence, gross negligence, negligence per se, strict liability and/or liability under the Deceptive Trade Practices Act or other fault regardless of cause or whether caused by the sole, joint, comparative, or concurrent negligence, gross negligence or fault of the FESTIVAL, my own fault or the fault of third parties, the conditions of the event site or any other cause. To INDEMNIFY means to assume the liability in a situation, thereby relieving the other party of responsibility.

I recognize that various photographs, video recordings and/or other media will be taken during the FESTIVAL's activities. I agree to grant the FESTIVAL full permission to use any photographs, video recordings, or other media of the FESTIVAL activities that contain my likeness for the purpose of promoting the FESTIVAL or its SPONSORS in any manner deemed appropriate by the FESTIVAL. I further agree to RELEASE and INDEMNIFY the FESTIVAL for any claims of NEGLIGENCE, GROSS NEGLIGENCE, NEGLIGENCE PER SE, STRICT LIABILITY or LIABILITY under the DECEPTIVE TRADE PRACTICES ACT or other fault for claims made that relate to any usage of photographs and/or interviews, including but not limited to damages, losses, costs of defense, attorney's fees and whether caused by the sole, joint, comparative or concurrent negligence, gross negligence or fault of the FESTIVAL or myself or third parties, the conditions of the event site or any other cause.
